Application Number: CH/21/009

Location: Cannock Chase Enterprise Centre, Walkers Rise, Hednesford **Development:** Removal of existing 17.5m slim-line telecommunications mast to be replaced by 20m mast to support 6no. panel antenna together with 3no. transmission dishes, ERS units and ancillary development thereto.

The Council noted that planning permission had been granted on 6 May 2021.

The Clerk advised the Committee that when a response had been received from the Enforcement Officer, answering questions about the display of banners in the Cannock Chase AONB, the information would be shared with Members.

Building Work

Councillor Pearson reported on his observation that a lot of building work seems to be in progress in the Hednesford area at present and he wondered whether this was reflective of the situation in Brindley Heath also. It was not known whether all applications had sought planning approval as relaxation of planning rules means that planning permission is not always required.

Land off Stafford Brook Road

The Chairman advised the Committee that the Enforcement Officer had been in touch with the owner of the land off Stafford Brook Road and will be making an inspection in due course. A big effort had been made to tidy the land up by the occupier.
