7. UPDATES ON OTHER PLANNING MATTERS

Stafford Brook Road

An update was given on the concerns of a resident in respect of two separate developments on neighbouring land, and the quality of information and support offered by the Planning Department. A site visit by Planning Control Committee Members had been requested but not undertaken.

Field off Shooting Butts Road

Residents have made enquiries about whether a planning application (for Change of Use) is a necessary requirement when agricultural land is used for business purposes rather than recreational.

Stafford Brook Road

It was suggested that the owner of a property be approached to ask whether an accumulation of unsightly items within the curtilage of the premises would soon be moved. It was agreed that an enquiry would be made by a member of the Parish Council.

Tackeroo Campsite, Penkridge Bank Road

It was reported that the Tackeroo Campsite was being hired out for many different uses which include cycle events. The view has been expressed many times that too many cyclists are using Cannock Chase which is considered damaging to the environment, and the loud halers used disrupt the peace and quiet within the AONB.

Kingsley Wood Road

Questions were raised about whether a development in Kingsley Wood Road occupies a bigger footprint than the approved plans.
